Selected verdicts of Ringler include a class action for \$160 million on behalf of doctors defrauded by an insurance company, \$30 million for the parents of an infant who suffered brain damage due to hospital negligence, \$16 million for a corporation which was the victim of theft of their trade secrets, \$10 million for an injured construction worker who fractured his hip

due to the negligence of a general contractor, \$8.9 million for a rail commuter passenger who suffered post-traumatic stress disorder as a result of the railroad's negligence, \$7.5 million for an injured motorist who could not recall the accident and where all witnesses ascribed fault to the plaintiff, and \$3 million for an individual who was the victim of corporate stock fraud.

Ringler is a member of the International Academy of Trial Lawyers and is a Diplomat of the American Board of Trial Advocates (ABOTA). Ringler has been included in the Top 100 LA County Super Lawyer list in 2004, 2005 and 2006. He has been listed in "The Best Lawyers in America" since its inception. Ringler has served as President of the Los Angeles Trial Lawyers Association and as a Master of the ABOTA American Inns of Court. He was named on two occasions "Trial Lawyer of the Year" by both the Los Angeles Trial Lawyers Association and Verdictum Juris.
